### REGISTRATION INFORMATION AND GUIDELINES

**Registration Fee \$ \_\_\_\_\_** Includes: Ready Set Grow T-shirt, schoolbag, and gym shoes.

**School Year Tuition: Deposit-** January & June tuition fees, plus the registration fee are due upfront upon registration and are non-refundable. The tuition balance will be split into 2 payments & will be due on the 1<sup>st</sup> of February & March.

A credit card is required to be on file for all registrations regardless of form of payment. If the agreed payment arrangement is not met by the 14th of each month due, this credit card will be automatically charged the tuition fee.

**Summer Camp Tuition:** Full tuition is due at the time of registration. Refunds are only given before the child has attended the 1<sup>st</sup> day of camp.

**Discounts:** Sibling tuition discount- \$50.00 / Sibling Registration Fee \$100.00

**Payment:** There is a 3% surcharge for any credit/debit card payment transaction (We do not accept American Express or Discover cards). There are no fees for cash or bank check payments.

**Registration Guidelines:** To ensure your child's enrollment spot for January you will need to fill out the registration form with your 1st, 2nd and 3rd choice of class, times and days accompanied by a non-refundable registration fee plus a non-refundable tuition deposit. We cannot enroll or hold a spot for your child unless we have a completed registration form and deposit payment. Ready Set Grow Preschool is a subsidiary of The Progressive Athletic Center (The PAC). Please make checks out to, The PAC, and put your child's full name on the check.

There are no refunds or make-ups for school closings due to severe storm or dangerous road conditions, when we feel the safety of the children and their parents may be endangered. There are no makeups or refunds granted for missed classes due to illness, play dates or "personal family vacations" during the regular school calendar year.

N.Y.S. law requires that all nursery schools have the proper medical form on file for each child. This information must be supplied by the parent prior to the start of our program.

Ready Set Grow reserves the right to ask a student, at any time, to withdraw because of improper conduct or unsafe behavior. All tuition fees are automatically forfeited. Ready Set Grow reserves the right to cancel, combine or reschedule classes due to lack of enrollment. If a student withdraws because of emergency medical circumstances, a tuition credit is applied. A request for any refund must be in writing accompanied with a doctor's note.

In case of a school closure due to a pandemic, Ready Set Grow will continue to provide program curriculum via virtual learning. Tuition fees will be billed at a reduced rate. If you should choose not to participate, there are no refunds given for unused tuition, only a credit will be issued. Tuition credit must be used within one year of the credit being issued.

Be aware that amendments may be made to our current registration guidelines to stay in accordance with any new mandates from the DOH, CDC, or State of New York. Parents will be notified & sign off on any new amendment and be accountable for adhering to it.

## READY SET GROW REFUND POLICY

Registration fee & tuition deposits are non-refundable.

Subsequent tuition payments are refundable prior to the first day of class. After the first day of class, tuition payments are non-refundable and parent is responsible for full year tuition.

A tuition credit would only be issued if the parent withdraws their child for emergency medical circumstances. A request for any credit must be in writing, accompanied with a doctor's note. Other than that reason, no refunds are given for any other reasons including moving out of town.

In case of a school closure due to a pandemic or pandemic related reason, Ready Set Grow will continue to provide program curriculum via virtual learning. Tuition fees will be billed at a reduced rate.

In the event that schools are mandated to close by the DOH, CDC, or State of New York, there are no refunds. There is tuition credit only.

Tuition credit must be used within one year of the credit being issued.

Ready Set Grow reserves the right to ask a student, at any time, to withdraw because of improper conduct or unsafe behavior. All tuition fees are automatically forfeited.
